Wood flooring quote for Mark Yawberg, for the rec. center of Trailer Estates.

Lightly sand areas near the stage where finish is completely worn off and apply one coat of water based sealer.

Cost: \$ 400.00

Clean and lightly abrade entire parquet floor and apply two coats of "Traffic" satin finish with a spread rate of approximately 500 sqft/gal.

Cost: \$ 6,200.00

If "Pro Coat" satin (equivalent of "Traffic") is used there would be a savings of \$ 800.00.

Optional coat for about thirty foot wide section in front of stage would cost \$ 800.00 for "Traffic" or \$ 700.00 for "Pro Coat".

Deposit of 60% and 40% due upon completion.
