OVERNIGHT PARKING

PURSUANT TO FLORIDA STATE STATUTE, 715.07, ALL OVERNIGHT PARKING ON TRAILER ESTATES PARK & RECREATION DISTRICT PROPERTY IS PROHIBITED EXCEPT BY PERMIT ONLY. (SEE ADDENDUM "C")

1. SIX DAY PARKING PERMITS MAY BE REQUESTED AT THE DISTRICT OFFICE BY ANY PROPERTY OWNER, RESIDENT OR ANY AUTHORIZED AGENT FOR THEIR OWN AND/OR A GUEST'S VEHICLE.
2. OCCUPANCY IS LIMITED TO THREE NIGHTS IN SELF CONTAINED VEHICLES ONLY.
3. THE TRAILER ESTATES SHUFFLEBOARD CLUB MAY OBTAIN THREE DAY PERMITS FOR RVs OF THOSE PARTICIPATING IN A TRAILER ESTATES SHUFFLEBOARD CLUB SPONSORED TOURNAMENT.
4. THE FOLLOWING ACTIVITIES ARE PROHIBITED:
 - A. **NO PETS**
 - B. IDLING OF VEHICLE'S MOTOR FOR MORE THAN TEN (10) MINUTES AT ANY TIME EXCEPT WHILE PARKING OR JUST PRIOR TO DEPARTURE.
 - C. OPERATION OF ANY AUXILIARY MOTOR (E.G. REFRIGERATION UNIT OR GENERATOR).
 - D. PARKING OF COMMERCIAL VEHICLES OVERNIGHT/PARKING OF NEW MOBILE HOMES OVERNIGHT
 - E. DESCHARGING OF ANY WASTE.
5. ANY VEHICLE FOUND VIOLATING THIS PARKING REGULATION SHALL BE TOWED AWAY AT THE OWNER'S EXPENSE.
6. THIS REGULATION SHALL BE PRINTED ON THE BACK OF THE PERMIT ISSUED BY THE DISTRICT.
7. IN COMPLIANCE WITH SECTION 715.07, PROPER SIGNS SHALL BE POSTED.
8. EXTENSIONS AND EXEMPTIONS TO THIS PARKING REGULATION MAY BE MADE BY THE DISTRICT'S BOARD OF TRUSTEES.
