ORDER OF REFERRAL TO MEDIATION

THIS CAUSE is referred to mediation in accordance with the mediation rules of the Florida Rules of Civil Procedure. Accordingly, it is,


ORDERED AND ADJUDGED:

1. **Appointment of Mediator.** All parties are required to participate in mediation and shall file a written stipulation naming a mediator within (10) days of the date herein.
2. **Scheduling.** Plaintiff's counsel shall coordinate the mediation conference. Within 15 days herein, counsel shall consult with each other and with the mediator to set a mediation conference. Said conference shall be held in no later than 90 days from the date hereof unless otherwise agreed by the parties. Plaintiff's counsel shall notify, in writing, all counsel of record of the date and time agreed for mediation.
3. **Mediator Fees & Report.** In the absence of a written agreement, the mediator fee shall be \$150.00 per hour, to be paid equally by each party.

The mediator must submit a report to the assigned judge immediately upon completion of mediation.

4. **Sanctions.** Failure to comply with the mediation rules or this order will result in sanctions by the Court.
