

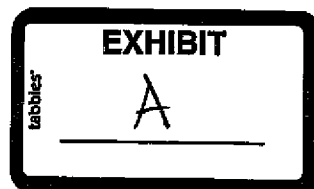
ACKNOWLEDGMENT OF RECEIPT OF SUBPOENAS AND WITNESS CHECKS






