This correspondence is to confirm that we will be coming out to Trailer Estates for inspection of all public records produced in accordance with our July 26, 2007, public records request. In our conversation on August 16, 2007, you specified that the District intends to charge us twenty-five dollars per hour, totaling one hundred dollars, for clerical services expended in relation to our public records request. It is my understanding from our prior conversation that the District does not have a policy relating to the charges for clerical assistance when public records are inspected but not copied. If the District does have a policy regarding charges for extensive clerical assistance when public records are inspected; please forward it to my office immediately. As discussed, it is our position that not having such a policy in place contravenes AGO – 00-11. Despite our differing opinions on the governing laws on this matter, we will agree to pay the \$100.00 at this time, so that we may view the public records requested. 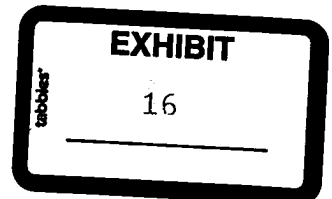
