OBJECTION TO SUBPOENA DUCES TECUM DIRECTED TO JANE LEDUC

COMES NOW the Defendant, Trailer Estates Park and Recreation District (“hereinafter referred to as “Trailer Estates”), by and through its undersigned counsel, and hereby objects to Plaintiffs, Sharon Denson and Mary Lou Smith’s, Notice of Taking Deposition Duces Tecum of Jane LeDuc and as grounds thereof states:

1. On November 23, 2009, counsel for Trailer Estates received a Notice of taking Deposition Duces Tecum of Jane LeDuc scheduled for December 3, 2009.
2. Pursuant to *Pembroke Park Lakes, Inc. v High Ridge Water Co.*, 186 So. 2d 85 (Fla. 3d DCA 1966), a subpoena duces tecum may not be used for the purpose of requiring a party to produce any documents or things in a discovery proceeding.
3. Ms. LeDuc is a resident of Trailer Estates. As such, any documents which are responsive to the Subpoena Duces Tecum maintained in Trailer Estates’ records have been

improperly requested via the Subpoena Duces Tecum unless good cause is shown.

WHEREFORE, Defendant, Trailer Estates Park and Recreation District, respectfully request this Honorable Court to require the Plaintiffs, Sharon Denson and Mary Lou Smith, to show good cause as to why the District should have to produce any documents or things in response to the Subpoena Duces Tecum directed to Jane LeDuc.
