TRAILER ESTATES TRUSTEES HAD A VACANCY (JOE FULMER) ON THE BOARD TO FILL AND ASKED FOR LETTERS OF INTENT FROM PARK RESIDENTS IN SEPTEMBER. TWO RESIDENTS SENT LETTERS:

TOM FEATHERINGILL

BRUCE SMITH (DOCK MASTER)

IT HAS BEEN A PAST PRACTICE OF TRUSTEES TO INTERVIEW APPLICANT'S FOR A BOARD VACANCY.

SECTION 11. (T.E. CHARTER). "ALL VACANCIES OCCURRING IN THE BOARD OF TRUSTEES FOR ANY CAUSE SHALL BE FILLED FOR THE UNEXPIRED TERM BY THE REMAINING TRUSTEES BY THE APPOINTMENT OF A SUCCESSOR TRUSTEE OR TRUSTEES FROM AMONG THE QUALIFIED ELECTORS OF SAID DISTRICT AS HEREIN DEFINED."

AFTER INTERVIEWS THE EXECUTIVE COMMITTEE MADE A RECOMMENDATION TO THE BOARD FOR TOM FEATHERINGILL BECAUSE AT THE TIME BRUCE SMITH (DOCK MASTER) WAS MUCH NEEDED FOR THAT VOLUNTARY POSITION. MARY LOU SMITH SENT A STRONG, CHAISTIZING LETTER TO THE BOARD AND CHAIRMAN FOR THEIR RECOMMENDATION. AT A REGULAR BOARD MEETING IN SEPTEMBER TRUSTEES VOTED FOR TOM FEATHERINGILL TO FILL THE VACANCY. TOM HAS YET TO BE SWORN-IN. THIS SITUATION HAS BEEN BLOWN OUT OF CONTEXT AND NOW COMPLAINTANTS WANT TO IGNORE SECTION 11 OF OUR CHARTER AND TURN FILLING A VACANCY ON THE BOARD INTO A CONDIDATES NIGHT.
