**ORDER CONTINUING TRIAL**

THIS CAUSE having come before the Court on Trailer Estates Park and Recreation District's Second Motion for Continuance of Trial, the Court on February 26, 2010, having heard District Counsel, Zac Ross' representations that lead counsel, Tom Shults would be unavailable for trial due to a medical condition and being otherwise fully advised in the premises, the Court FINDS:


1. Based on the representations of District Counsel, the request for continuance is made in good faith; and
2. This case is of significant magnitude, and involves intricate and complex issues of public records and sunshine law, which are specialized areas of the law, such that the District is entitled to proceed with its chosen lead counsel; and,

Therefore, it is hereby ORDERED:

1. The District's Second Motion for Continuance is granted and the 10 day trial presently set to begin the week of March 15, 2010, is continued.
2. The trial of this case is reset on the major trial docket for the period beginning October 4, 2010.
3. The Court grants leave to preserve testimony for trial by video deposition or appearance at trial by video conferencing to allow for testimony of witnesses who may not be present in Manatee County.
4. The Court denies Plaintiffs' Motion for Attorneys' Fees' related to District's Second Motion for Continuance.
