Dear Ms. Dietrichsen:

Our firm serves as general counsel to the Trailer Estates Park and Recreation District, a special-purpose unit of local government established pursuant to Chapter 2002-361, Laws of Florida. Pursuant to this special act, the business of the District must be conducted through the District's nine-member governing board. Unfortunately, we do not currently have enough Board members present in the state of Florida to obtain a quorum and take official action on behalf of the District, such as acceptance of a settlement offer in the above-referenced case.

The District staff has inquired with the Board members to determine when a meeting might be held, and it appears that October 4, 2010, is the soonest date that can be confirmed. As such, we are requesting an extension of the response deadline to October 6, 2010, so that the Board will have an opportunity to consider any settlement offers. We have already begun discussions with Marc Drexler, the Department's lead attorney on the case, and hope to have a settlement finalized during this timeframe.
